Project Overview

MRP – Maintenance and Renewal Program

The MRP program aims to extend building lifecycles through proactive and predictive maintenance. To achieve this, TFC monitors building conditions, updates the Master Facilities Plan, and secures funding for maintenance and renewal programs to ensure State-owned buildings remain operational throughout their lifecycles.

For example, a roof with a 20-year lifespan would require replacement four times to meet a 100-year building lifecycle goal. Similarly, common spaces are updated systematically, while tenant space improvements are coordinated with tenant agencies as needed.

William B. Travis Building

\$30 million multi-year project includes these building updates:

- Major renovation of the main lobby
- Remodel of two first-floor conference rooms and the TEA Commissioners' Room
- A consolidation and major refresh of TEA workplace on floors 1, 2, and 3.
- Refresh of workspaces on floors 5 & 6 (Tenant finish-out & TFC transition space)



When will the construction begin?


ANSWER:

Preplanning preparations and staging are underway. Active construction is planned to begin on January 27, 2025.

Will there be access to the building from the Mall?

ANSWER:

No. The building lobby will be closed on or about February 10, 2025. Tenants and visitors must enter the building on the ground floor near the café. See map.



Will the loading dock remain open for use?

ANSWER:

Yes. The loading dock will be available for tenant use. Please coordinate large deliveries with your property manager to ensure access to open bays.

When will the elevators be programmed for badge access?

ANSWER:

On January 27, 2025, the elevators will require a scan of your badge to access tenant floors.

Will there be access to the 7th floor conference room?
